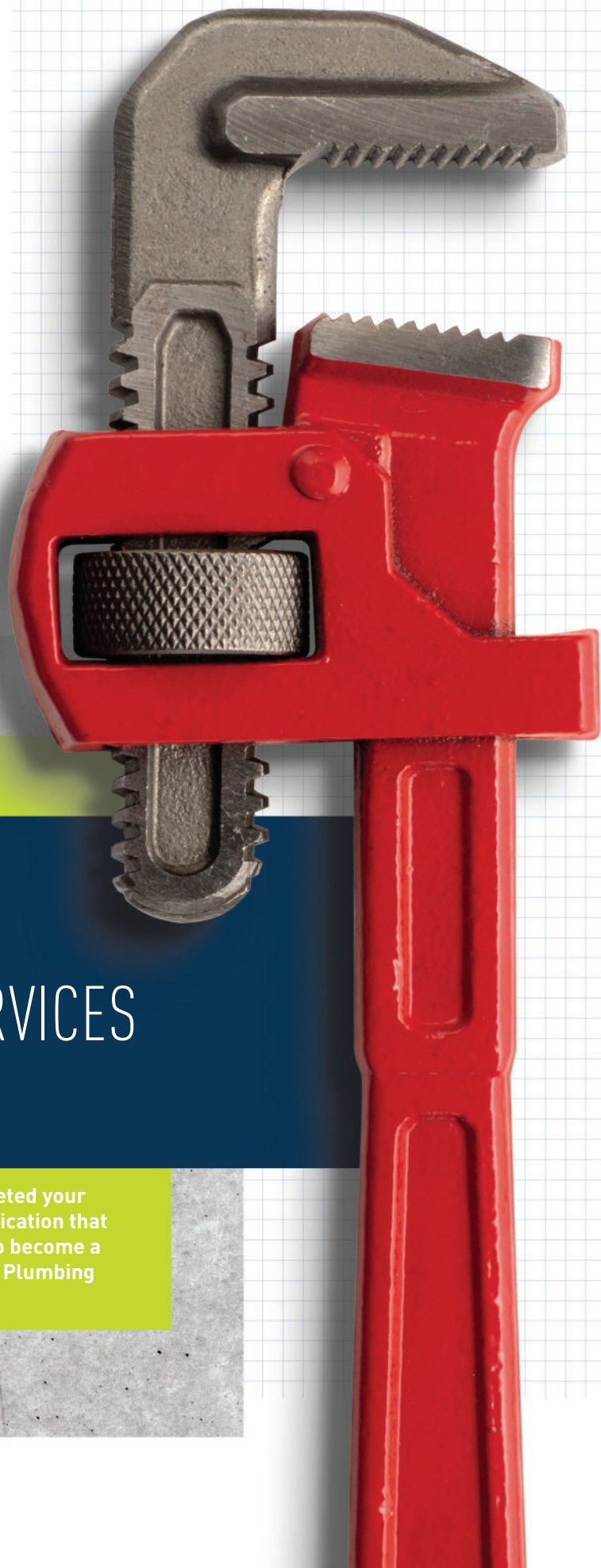

# CERTIFICATE IV IN PLUMBING AND SERVICES (OPERATIONS)

You're a registered plumber and you have completed your apprenticeship. The next step is to gain the qualification that will give you the skills and knowledge required to become a licensed plumber with CPC40920 Certificate IV in Plumbing and Services (Operations)

# IS THIS COURSE FOR YOU?

The unit selection in our CPC40920 Certificate IV in Plumbing and Services (Operations) program covers the skills and knowledge for the following plumbing licenses: Gasfitting Work, Drainage Work, Sanitary Work, Water Supply Work, Roofing (Stormwater) Work, Type A Appliance Conversion Work and Type A Appliance Servicing Work. Training and assessment for all units within this course will be undertaken in a real or closely simulated workplace environment, as required by the plumbing industry.

## Enrolment checklist

- You are over 18 years of age
- You have completed Certificate III in Plumbing
- You have completed CPCCWHS1001 Prepare to work safely in the construction industry
- You are competent in written and spoken English and have sufficient numeracy skills
- You are able to attend the scheduled classroom training sessions as per the timetable
- You will have access to a computer and the internet for the duration of the course
- You have your own plumbing tools for practical classes, please see our website for more details
- You have 8 hours free time a week to study outside the classroom

## How long will it take?

Part-time, two nights per week of facilitator-led classes for 41 weeks including 4 sessions of practical delivery of 7 hours duration. Students studying this qualification although completing over a minimum duration of 41 weeks, will typically complete all requirements over a total duration of between 41-47 weeks.

*\*This variation in the course duration is due to unavoidable class breaks, public holidays, and Christmas Shutdown period as applicable.*

Students may require up to 8 hours per week outside of class times to complete additional learning and assessment activities, yet this will vary based on each learner.

## Is the course subsidised?

This training is delivered with Victorian and Commonwealth Government funding for eligible students. Contact us to find out if you qualify. If not you can still enrol as a full fee student.

## Future pathways

After completing CPC40920 Certificate IV in Plumbing and Services (Operations) you are eligible to undertake the state assessment to become a licensed plumber.

## Units

Participants need to complete 15 units of competency, consisting of 10 core units plus 5 elective units. Unit selection for this course is for the Plumbing and Services - Operations stream which provides outcomes for licencing in Gasfitting, Drainage Work, Sanitary Work, Water Supply, Roof (Stormwater) work, Type A Gas appliance servicing work and Type A Gas appliance conversion work.
